Sir,

The following provisions of Mineral Conservation and Development Rules, 2017 were found violated in your above mine during the inspection on 06.03.2021 by the undersigned accompanied by Sri A.J.Reddy, Mines Manager.

Rule No.	Nature of Violation
40	Every holder of prospecting licence or a mining lease shall take all possible measure to keep air pollution due to fines, dust, smoke or gaseous emissions during prospecting, mining, beneficiation or metallurgical operations and related activities within permissible limits. “ During the inspection of the Mines it was observed that no measures for dust suppression were undertaken ”

02. In this connection, it is brought to your notice that the above said violations constitute an offence punishable under Rule-62 of MCDR, 2017.

03. You are advised to rectify the above violations immediately and intimate the position to this office within 45 (forty five) days from the date of issue of this letter.
