The following provisions of the Mineral Conservation and Development Rules, 2017 were found violated in your above mine during inspection on 17.02.2021 by undersigned in presence of Shri Vinodh Kumar NR, Mine Manager & Mining Engineer, Shri Brajesh Kumar, AGM Mines, Shri Nataraja B, Geologist and other mining officials:

	operation vis-à-vis approved document are given below.
11 (1)	i) Total 20,000 nos. saplings to be planted in Greenbelt development & area under
	encroachment against which only 1160 nos. of total saplings are planted for the year
	2019-20.
28(1)	It was reported during inspection that the Mine was not in operation since Dec-
	2019. The notice of temporary discontinuance of work in mines has not been sent as
	per the provision of this rule in Form-E.
29	It was reported during inspection that mine is under operation after temporary
	discontinuance on 17.02.2021. The intimation of reopening of mine after temporary
	discontinuance in Form-C has to be submitted as per the provision of this rule.
55	A whole time ''Geologist' has not been appointed as per the provision of this rule.

- 02. In this connection, it is brought to your notice that the above violations constitute an offence punishable under Rule 62 of MCDR, 2017.
- 03. The mining operations can be suspended under rule 11(2), if compliance of rule 11(1) is not found satisfactory.
- 04. You are advised to rectify the above violations immediately and intimate the position to this office within 45 (Forty Five) days from the date of issue of this letter.
