Sub: Violation of provisions of Mineral Conservation and Development Rules, 2017 in respect of your Pagadapalli Iron ore & Laterite Mine (30APR04005) over an extent of 201.914 ha. of Pagadalapalli Village, Pendlimarri Mandal, YSR Kadapa District, Telangana.

Sir

The following provisions of Mineral Conservation and Development Rules, 2017 were found violated in your above mine based on the scrutiny of records.

Rule No.	Nature of Violations observed
11 (1)	No holder of a mining lease shall commence or carry out mining Operations in any area except in accordance with the mining plan approved, modified or reviewed by the Indian Bureau of Mines. The Mining Plan for the document was approved vide letter No. 659(532)/IRON ORE & LATERITE/2005/HYD dated 08.05.2017, which expired on 31.03.2021. Since then you are not having a valid Review of Mining Plan document of the lease hold area. Since you have no approved document, it is evident that the mining operations were not being carried out in accordance with it.

- 02. In this connection, it is brought to your notice that the above violations constitute an offence punishable under rule 62 of MCDR, 2017. Further, inability to comply the provision of Rule 11(1) is liable for suspension of mining operations under 11(2) of MCDR, 2017.
- 03. You are advised to rectify the above violations immediately and intimate the position to this office within 45 (Forty Five) days from the date of issue of this letter.
