Sub: Violation of provisions of MCDR, 2017 in respect of Ravirala(Reserve Forest) Limestone Mine over an area of 60.72 ha in Ravirala village, Krishna District, Andhra Pradesh.

Sir,

The following provisions of Mineral Conservation and Development Rules, 2017 were found violated in your above mine during the inspection on 25.02.2022 by the undersigned accompanied by Sri P.Jani Reddy, Agent(Mines).

Rule No-	Nature of violation
11 (1)	No holder of a mining lease shall commence or carry out mining operations in any area except in accordance with the mining plan approved, modified or reviewed by the Indian Bureau of Mines or prepared and certified in accordance with the system established by the State Government pursuant to the proviso to clause (b) of sub-section(2) of section 5. “It was proposed to construct Retaining wall and Retaining Bund around the Passive dump on Western side and Active dump on Eastern side respectively. However, during the inspection it was observed that no such Retaining wall was constructed around the passive dump. Further, a partial safety bund was constructed around the active dump instead of a complete safety bund.”

02. In this connection, it is brought to your notice that the above said violations constitute an offence punishable under Rule-62 of MCDR, 2017. Further, inability to comply the provision of Rule 11(1) is liable for suspension of mining operations under Rule 11(2) of MCDR,2017.

03. You are advised to rectify the above violations immediately and intimate the position to this office within 45 (forty five) days from the date of issue of this letter.
