The following provisions of the Mineral Conservation and Development Rules, 2017 were found violated in your above mine during inspection on 22.02.2022 by Shri K. Srinivas, JMG in presence of Shri Brajesh Kumar, Mines Manager, Shri Nataraj B.D, Dy.Manager(Geology), Shri Paramesha K.M, Mining Engineer.

Rules	Nature of Violations observed
45(7)	 i) As per provision of Rule 45(5)(b) " a monthly return shall be submitted before the tenth day of every month in respect of the preceding month in electronic form". The monthly Return for the month of November,2021 has been submitted on 10th December 2021, which is after the due date.

- 02. The Mining operations and dispatches may be suspended and any action under subrule (7) of Rule 45 of MCDR 2017 read with MCDR (Amendment), 2021 may be initiated.
- 03. In this connection, it is again brought to your notice that this violation also constitutes an offence punishable under Rule 62 of MCDR (Amendment), 2021.
- 04.You are therefore, directed to show cause within a period of thirty (30) days from the date of issue of this notice, as to why action under subrule (7) of Rule 45 and Rule 62 of MCDR 2017 read with MCDR (Amendment), 2021 shall not be taken against you.
