The following provisions of the Mineral Conservation and Development Rules, 2017 were found violated in your above mine during inspection on 25.02.2022 by the undersigned in presence of Shri Ashok Kumar Joshi, Mines Manager, Shri Vijaya Kumar, Mining Engineer.

In case of Captive mines, the Ex-mine price per tonne is the per unit cost of production.</p> <p>Part-VII: (b) The correct figure may be furnished under Exploration in the table of Cost of Production if There is exploration carried out for the year 2020-21.</p>

02. The Mining operations and dispatches may be suspended and any action under subrule (7) of Rule 45 of MCDR 2017 read with MCDR (Amendment), 2021 may be initiated.

03. In this connection, it is again brought to your notice that this violation also constitutes an offence punishable under Rule 62 of MCDR (Amendment), 2021.

04. You are therefore, directed to show cause within a period of thirty (30) days from the date of issue of this notice, as to why action under subrule (7) of Rule 45 and Rule 62 of MCDR 2017 read with MCDR (Amendment), 2021 shall not be taken against you.

05. You are herewith given 30 days time for reply and rectification of the violation from the date of issue of this notice.
