विषय/Subject: Violation of provisions of MCDR 2017 in respect of your Chittapur Limestone Mine, ML 2588 over an extent of 796.4 ha (as per lease dead), in Ravoor Village, Chittapur Taluk , Gulbarga District of Karnataka State.

Sir,

The following provisions of the Mineral Conservation and Development Rules, 2017 were found violated in your above mine during inspection on 25.02.2022 by the undersigned in presence of Shri Ashok Kumar Joshi, Mines Manager, Shri Vijaya Kumar, Mining Engineer.

Rules	Nature of Violations observed
11 (1)	Review and Updation of Mining Plan was approved by IBM vide letter no. 279/659/99/BNG dated 19.04.2018, for the period 2018-19 to 2022-23 The deviations observed in mining operation vis-à-vis approved document are given below. i)It was observed during site inspection that 24 exploratory boreholes with 960 m merterage has been proposed during the year 2020-21. However, the same has not been carried out so far. ii) It was observed during the inspection that during the year 2020-21, the plantation of 700 saplings has been proposed along the safety zone in western part of the lease boundary. The same has not been carried out.

02. In this connection, it is brought to your notice that the above violations constitute an offence punishable under Rule 62 of MCDR, 2017.
03. The mining operations can be suspended under rule 11(2), if compliance of rule 11(1) is not found satisfactory.
04. You are advised to rectify the above violations immediately and intimate the position to this office **within 45 (Forty-Five) days** from the date of issue of this letter.
