বিষয/Sub: Violation of provisions of Mineral Conservation and Development Rules, 2017 in respect of your Karadikolla Iron Ore Mine (ML No. 0010) over an extent of 86.12 Ha in Siddapur village, Sandur Taluk, Ballari District, Karnataka state.(MINE CODE:30KAR03187)

महोदय/Sir,

The following provisions of the Mineral Conservation & Development Rules, 2017 were found violated in your above mine during the inspection carried out by the undersigned along with Shri. H.M.Shivakumar-Assistant Mining Engineer in presence of Sri. K.Madhusudhan, Agent and VP (Mines & CC), Sri.Dasharatha.R Manager (Mines) & Shri.Muralidhar.T–Mining Engineer on 16/02/2022.

Rule	Nature of violations observed
11 (1)	The Mining operations are required to be carried out in accordance with the approved Mining Plan document vide letter no. 279/1094/2017/BNG dated 24/10/2017, However, during the inspection deviations were observed in mining operation vis-à-vis approved document and are as follows: (i) As per the aforesaid approved document, It is proposed to transport ROM from blasting face to crusher /stack ROM nearer to crusher in the area earmarked between section S-2 – S-2' and 2 & S-1 -2 & S-1' in North western part of the Mining Lease. However, during the inspection, it is observed that a large quantity of ROM is stacked which is extending beyond the area earmarked in the approved Mining Plan.

(i) As part –II A 1. (iv) of the Annual Returns submitted for FY 2020-21, Capitalised Expenditure such as pre-production exploration is not accounted for the exploration carried out during the year. (ii) As part –III-2 of the Annual Returns submitted for FY 2020-21, Royalty and Rents: It is observed on verifications of the records at Mine Site, the Amount of Royalty, DMF and NMET contributions made during the year is wrongly reflected. Accordingly part VII for Cost of Production per tonne be corrected. (iii) As per part VII of the Annual Returns submitted for FY 2020-21, DMF, NMET & Royalty paid details have not been furnished and accounted for arriving at the cost of Production.

- 02. In this connection it is brought to your notice that the above violations constitute an offence punishable under Rule 62 of MCDR 2017.
- 03. The violation of Rule 11(1) may also attract provisions of Rule 11(2) of MCDR, 2017 regarding suspension of mining operations till the compliance of violations.
- 04. You are advised to rectify/explain the above violations immediately and intimate the position to this office within 45 (Forty Five) days from the date of issue of this letter.
