विषय/Subject: Violation of provisions of MCDR 2017 in respect of your Narayana Iron ore Mine, ML 0012 over an extent of 107.51 ha(as per lease dead), in Narayanapura Village, Sandur Taluk , Bellari District of Karnataka State.

Sir,

The following provisions of the Mineral Conservation and Development Rules, 2017 were found violated in your above mine during inspection on 22.02.2022 by Shri K. Srinivas, JMG in presence of Shri Brajesh Kumar, Mines Manager, Shri Nataraj B.D, Dy.Manager(Geology), Shri Paramesha K.M, Mining Engineer.

Rules	Nature of Violations observed
11 (1)	Modification to the approved Mining plan was approved by IBM vide letter no. 279/1105/2019/BNG/930 dated 21.12.2020, for the period 2020-21 to 2024-25. The deviations observed in mining operation vis-à-vis approved document are given below. i)It was observed during site inspection that the dumping of waste has been proposed in the location between 1657445N & 678038E and 1657639N & 678300E during the year 2020-21. The same has not been carried out in the proposed area.
	ii) It was observed during the inspection that during the year 2020-21, the construction of retaining wall of 266m, Garland drain of 271m and one silt settling Tank of 20m x10m x 3m has been proposed. The same has not been carried out.

- 02. In this connection, it is brought to your notice that the above violations constitute an offence punishable under Rule 62 of MCDR, 2017.
- 03. The mining operations can be suspended under rule 11(2), if compliance of rule 11(1) is not found satisfactory.
- 04. You are advised to rectify the above violations immediately and intimate the position to this office within 45 (Forty-Five) days from the date of issue of this letter.
