	2016. The Review of Mining Plan of above mentioned mine was approved vide this office letter No-MP/SATNA/LST/RMP-49/2019-20 dated 30.06.2020 incorporating the proposals of working from 2020-21 to 2024-25. During the inspection it was found that following provisions of rule have been violated.

	During the inspection it was found mine Geologist and Mining engineer were appointed in the mine but intimation of their appointments were not sent to the Regional Controller of Mine, Jabalpur till the date of inspection.
