Sub: Violation of provisions of Mineral Conservation and Development Rules-2017 (MCDR-2017) in respect of your Chanda Manganese Ore Mine over an extent of 39.27 Ha in Chanda Village, Adilabad Mandal & District, Telangana state.

The following provisions of Mineral Conservation and Development Rules 2017 (MCDR, 2017), were found violated in your above mine during inspection on 3/1/2021 by the undersigned accompanied by your goodself.

02. In this connection, it is brought to your notice that the above violation constitutes an offence punishable under rule 62 of MCDR, 2017. Besides inability to comply the provision of rule 45(7) is also liable for suspension of mining operations under the provision of rule 45(7) (a) (i) or other action under rule 45 (7)(a) MCDR, 2017.

03. You are advised to rectify the above violations immediately and intimate the position to this office within 45 (forty-five) days from the date of issue of this letter.
