The following provision of Mineral Conservation & Development Rules, 2017 were found violated in your above mine during the inspection on 08/12/2020 by the undersigned in presence of Shri M. Udapudi and Shri N.Murthy, Lessee representative

11(1)	Mining operations have not been carried out in accordance with the modification of
	Mining Plan approved vide MP/OTF.MECH-02/GOA/2016-17 dated 08/02/2017.
	Working benches in both limestone and dolomite pits, from E5354450 to E535600
	were not found to be maintained systematic and scientific manner as loose boulders
	were found scattered all over the benches were found to be maintained disorienented
	and zigzag manner. The aforesaid violation was pointed out by this office vide letter
	even no, dtd 28.02.2020. However, it has observed in the office record that the
	outstanding violations are not complied so far.
35(2)	Every holder of a mining lease shall monitor his mining and allied activities as per the
	notified template of star rating in the format prescribed in this behalf by the Indian
	Bureau of Mines from time to time, and shall submit online its selfassessment report
	before the 1st day of July every year for the previous financial year, alongwith the soft
	copy (in the standard format), of high resolution satellite images obtained from
	CARTOSAT-2 satellite LISS-IV sensor on the scale of cadastral map, as on the 31st
	day of March for that financial year, covering the mining lease and an area of two
	kilometres. from the lease boundary, to the Regional Controller or the authorised

	officer of the Indian Bureau of Mines.
11(1) &	An yearly report on progressive Mine closure Plan before 1 st July of every year setting
26(2)	forth the extent of protective and rehabilitation work carried out as envisaged in the approved progressive Mine closure plan has not been submitted for the year 2019-20.
55(1) (c) (i)	For the purpose of carrying out reconnaissance, prospecting or mining operations in accordance with these rules: "Every holder of a mining lease shall employ, in case of category 'A' mines, a full time mining engineer and a full time Geologist". However during the inspection it was observed that a full time Mining Engineer and Geologist has not been employed under this rule.
33	The updated Plans and sections as required under rule 32 are not submitted/maintained.

- 02. It is observed from the office record that you have not complied the violation issued by this on dated 28.02.2020 so far. Further, it has observed from the office records that the some violations are in repeated in nature from the long back. This shows that, no action were taken from the your end to rectify the outsndaing violations of the rule 11(1), 26(2), 35(2) and 55(1) of MCDR, 2017.
- 03.In this connection, it is brought to your notice that the above violation constitutes an offence, punishable under Rule 62 of MCDR, 2017.
- 04. You are therefore, directed to show cause within period of **thirty** (**30**) days as why you should not be prosecuted for the above offence and/or why mining operations shall not be suspended as per provision of rule 11(2) of MCDR,2017...
- 05. Please note that no further notice will be given to you in this regards.
