Sub : Violation of provisions of Mineral Conservation & Development Rules, 2017 in respect of your Girgaon Rengewadi Bauxite Mine,(Mine Code 07MSH13013 Area-304.72Ha, M/s Shivram Minerals in Kolhapur District of Maharashtra State.

Sir,

The following provision of Mineral Conservation & Development Rules, 2017 were found violated in your above mine during the inspection on 05/12/2020 by the undersigned in presence of Mr. Pravin V. Likhar, Mines Manager.

Rule	Nature of Violation observed
45(5)	The holder of a mining lease shall submit online returns in respect of each mine to the Regional Controller a monthly return which shall be submitted before the tenth day of every month in respect of the preceding month in electronic form along with a signed print copy of the same if it is not digitally signed However, it has observed that the monthly returns for the month October and November were not submitted so far.
46	Notice of appointment of Geologist in Form – H has not submitted to this Office.
35(2)	Every holder of a mining lease shall monitor his mining and allied activities as per the notified template of star rating in the format prescribed in this behalf by the Indian Bureau of Mines from time to time, and shall submit online its selfassessment report before the 1st day of July every year for the previous financial year, alongwith the soft copy (in the standard format), of high resolution satellite images obtained from CARTOSAT-2 satellite LISS-IV sensor on the scale of cadastral map, as on the 31st day of March for that financial year, covering the mining lease and an area of two kilometres. from the lease boundary, to the Regional Controller or the authorised officer of the Indian Bureau of Mines.

However, it has observed that the aforesaid submission are not made so far.

02. In this connection, it is brought to your notice that the above violation constitutes an offence, punishable under Rule 62 of MCDR, 2017.

03. You are advised to rectify the above violation immediately and intimate the position to this office within 45 (Fourty five) days from the date of issue of this letter.
