MMP/Man-02(KNT)/Goa/2017-18, dated 20.02.2018 to the extent indicated below:- (i) As per the approved MMP, the mining operation are proposed to be carried by manually with systematically mining by reducing the existing bench heights to 3m within two years. However, during the inspection it has observed that the mining operation is being carried out without reducing the bench heights, with the bench height between 5-6 meters. (ii) Minerals are observed to be stacked adjascent to the mining leases area. |
| 45(7) | The domestic sale of mineral were carried out to the some buyers without having registration number as allotted by Indian Bureau of Mines. |
| 55(1)(c) | The Mining Engineer and Geologist required under these rule are not appointed. |

- 02. In this connection, it is brought to your notice that the above violation constitutes an offence, punishable under Rule 62 of MCDR, 2017.
- 03. The mining operations can be suspended under rule 11(2), if compliance of rule 11(1) is not found satisfactory.
- 04. You are advised to rectify the above violation immediately and intimate the position to this office within 45 (Fourty five) days from the date of issue of this letter.
