Sub :- Violation of provisions of Mineral Conservation & Development Rules, 2017 in respect of your Wanjri Limestone Mine, over an extent of 11.89Ha. Situated in Wanjri-village, Teh-Wani, Yavatmal District of Maharashtra State.

Sir,

The following provision of Mineral Conservation & Development Rules, 2017 were found violated in your above mine during the inspection on 27/01/2021, by Shri Kalmata.M.K, Regional Mining Geologist, in presence of Shri Avinash N Warwatkar, Lessee.


Rule	Nature of Violation observed
55 (6)	As per Rule 55(6) of MCDR-2017, a Mining Engineer as employed by the holder of a mining lease shall possess a degree in Mining Engineering granted by a University established or incorporated by or under a Central Act, a Provincial Act or a State Act, including any institution recognised by the University Grants Commission established under section 4 of the University Grants Commission Act, 1956 (3 of 1956) or any equivalent qualification. In the instant case Sh.G.M.Gedam is appointed as a Mining Engineer who is possessing Diploma in Mining, which is not qualifying as prescribed in the Rule.

02. In this connection, it is brought to your notice that the above violation constitutes an offence, punishable under Rule 62 of MCDR, 2017.

03.The mining operations can be suspended under Rule 11(2), if compliance of MCD Rules 2017 is not found satisfactory, or prosecution can be made, or both can be done.

04. You are advised to rectify the above violation immediately and intimate the position to this office within 45 (Fourty five) days from the date of issue of this letter.


