Sub: Violation of provisions of Mineral Conservation & Development Rules, 2017 in respect of your Lokapur Limestone Mine(M.L.No-2407) over an extent of 4.92 Ha. Situated in Lokapur village, Tq- Mudhol, in Bagalkot District of Karnataka State. Sir,

The following provision of Mineral Conservation & Development Rules, 2017 were found violated in your above mine during the inspection on13/02/2018(F/N), by the undersigned in presence of Shri Venkappa Ramappa B. Patil, Lessee.

Rule	Nature of Violation observed
11(1)	The following deviations were observed in the approved Scheme of Mining dated 7.11.2013.  a) The working has been not carriedout as per the proposal mentioned on the production and development plan for the year 2016-17 and 2017-18.  b) There was a proposal to dump waste in the Northern part of the lease area. However it was observed that Waste dumping is made in the working pit only.
	c) There was a proposal to maintain bench height 3mtr. However during inspection it is observed that bench height was made more than the proposal.
26(2)	An yearly report before 1st July of every year setting forth the extent of protective and rehabilitation work carried out as envisaged in the approved progressive mine closure plan has not been submitted for the year 2016-17 so far.
27(1) & 27(2)	The differential financial assurance for the mining and allied activities as per MCDR 2017 is not paid for the entire area as shown in the PMCP chapter of approved Modified mining plan within 90 days from the commencement of MCDR 2017.

Rule 48	Details of drilled boreholes are not recorded in the form-I.
55(1)(3)(iii)	The Mining Engineer and Geologist required under the said rule is not appointed by the lessee.

02. In this connection, it is brought to your notice that the above violation constitutes an offence, punishable under Rule 62 of MCDR, 2017.

## 03. The mining operations can be suspended under rule 11(2), if compliance of rule 11(1) is not found satisfactory.

04. You are advised to rectify the above violation immediately and intimate the position to this office within 45 (Fourty five) days from the date of issue of this letter.
