In this regard, you are directed to submit the Financial Assurance in the form of Bank Guarantee for the area put on use for Mining and allied activities @ Rs.Five lakhs/hectare for category 'A' mines provided that the minimum amount shall be Rs.Ten lakhs as per the provision of Rule 27(1) of MCDR, 2017 at the time of submission of final copies of the document within 15 (fifteen) days from the date of issue of this letter, failing which the document will be disposed without giving any further opportunity.
- 03. The para-wise clarification & the manner in which the deficiencies are attended should be given while forwarding modified document.

Scrutiny comments on examination of Modification of Mining Plan of Kanakadripalli Limestone Mine of M/s. The Ramco Cements Limited over an area of 435.24 Ha in Petnikota & Itikyala Village, KolimigundlaMandal, KadapaDistrict, Andhra Pradesh submitted under Rule 17 (3) of MCR 2016.

General

- 1. Reason for modification in the approved mining plan has to be submitted with due justification.
- 2. The document shall be submitted as per the format mentioned in the FAQ on format of Mining Plans issued vide CCOM Circular 1/2021 dated 08.09.2021.
- 3. The final document shall adhere the conditions stipulated in CCOM circular No. 01/2021dated 07.06.2021& FAQ on format of Mining Plans issued vide CCOM Circular 1/2021 dated 08.09.2021.
- 4. Status of implementation of CCOM Circular no. 2/2010 to be submitted.
- 5. Color photographs shall be enclosed as annexure for easy reference pertaining to boundary pillars, old mined out pit, dumps, afforestation, core logs, ground control points etc.
- 6. During inspection it has been found that mine working is being carried out in old quarry pit within the southern part of the mining lease area and it has been made to understand that it is being carried out by local people. A detailed report in this regard should be annexed.
- 7. Clarification is sought in the form of affidavit clearly stating that no issues related to illegal mining, royalty payment, public interest litigation and court case

4.9. Chemical specifications shall be submitted for all radicals of limestone in the proposed use of minerals.

5.2. Year wise proposal for the prospective period shall only be submitted for the CSR initiatives.

Chapter 6: Progressive Mine Closure Plan

6.1. Total area degraded shall be submitted correctly.

6.2.2.2. Proposals for protective measures like fencing, retaining wall shall be submitted.

Chapter 7: Financial Assurance/Performance security (Area put to use)

Financial assurance plan should be submitted on the basis of area put to use for mining allied activities and in view of above comments and the amount shall be submitted in the form of Bank Guarantee as per Rule 27 of Mineral Conservation and Development (Amendment) Rules, 2021.

Chapter8: Review of Previous Proposals

8.1.1. Area proposed under activity shall be submitted correctly in the lease area utilization table.

Plans & Sections:

1. Surface plan is not updated and last survey carried out was not mentioned. Hence old slab quarry dump material in the lease was not assessed properly. Updated plans and sections should be submitted.

2. Conceptual plan to be prepared for the entire lease area showing UPL, life of the mine, conceptual exploration, pit dimension, land use pattern, status of reclamation and rehabilitation, land use, position of pit, dumps, dump re-handling proposals, green belt development etc. at the end of this 5 year period and at the end of the lease period.

3. Plans and sections not submitted as per the conditions stipulated in CCOM circular No. 01/2021dated 07.06.2021 & FAQ on format of Mining Plans issued vide CCOM Circular 1/2021 dated 08.09.2021.

4. Proposals shall be submitted in .kml or.shp files in the form of soft copies.
