Scrutiny Comments on the Review of Mining Plan submitted of Bhavanipuram Limestone Mine of M/s Deccan Cements over an extent of 183.11 ha in RavipahadVillage,SuryapetDistrict,Telangana State.

- 1. On the cover page, the rule mentioned was as per MCDR, 1988 this needs to be changed.
- 2. In the certificate given in the beginning, it is mentioned that the document is submitted under Rule 17(3) of MCR, 2016, whereas it is mentioned in the cover page that it is submitted under Rule 17(2) of MCR, 2016. As there is extension of lease period by State Government, a modified document under rule 17(3) of MCR, 2016 needs to be modified at all relevant places.
- 3. The area covered under G1/G2/G3/G4 need to be specifically mentioned at para 6.4.
- 4. A note on the capacity of the plant vis-à-vis the production and reserves/resources for feeding the plant from both the mining lease to be furnished.so as to enable proper planning and excavation of mineral. The proposals should be in accordance with the installed capacity of the plant.
- 5. In page no.57 at para 7.26 it was mentioned that ROM will be blended with subgrade mineral. However, on page no.61 at para 10.2 it was mentioned that there will be no generation of sub grade mineral. These statements need to corrected.
- 6. The Financial Assurance as mentioned in the para no.14.3.12 to be submitted along with final copies.
- 7. A copy of the permission letter obtained for using HEMM to be enclosed as annexure.
- 8. As the lease area falls under forest, relevant forest clearance documents need to be enclosed as annexures.
- 9. At para 7.20 under table proposed afforestation it was mentioned that 1500 saplings will be planted every year. During the ensuing plan period. However, as per the annexure II i.e. MOEF clearance, it was mentioned that every year with a density of 2500 saplings per hectare need to planted. Accordingly the plantation proposals need to be revisited.
- 10. In plate No.IVi.e. Surfaceplan, date of survey was not mentioned.
- 11. In plate no. VA i.e. Geological sections, at I-I', J-J' & K-K', a power line/seasonal nala are passing through the lease, a line showing the barrier zone to be marked on the sections.
- 12. In plate no. VIII i.e. Environment plan, Environment monitoring stations for Air quality/water quality/soil quality and noise quality are not marked, the same should be incorporated.
