The following provisions of Mineral Conservation and Development Rules, 2017 (MCDR, 2017) were found violated in your above mine during inspection of the mine on 20.01.2022 by the undersigned accompanied by Sri Mahipal Reddy Mining Engineer.

31(4)	The plans and sections required under these rules shall be maintained up to date within three months in case of category 'A' mines as referred to in clause (a) of sub-rule (2) of rule 55, and within twelve months in the case of any other mine.
	Plans and sections have not been found maintained updated as required under the provision of this rule.
45 (5)	Discrepancies are observed in the Annual returns submitted for the year 2020-21 as below:
(7)	i. Part-I: item 11: Date of execution of Mining Lease deed is furnished as 20.02.2018, instead of initial date of execution of lease i.e. 28.03.1991.
	ii. Part-I: item 12: Area put to use under Infrastructure facilities like Over Bridge, Haul Road etc. are not furnished.
	ii. Part-II: Item 1, Value of fixed assets of Rs. 4799661 is cumulative figure not accounting for single lease, therefore details of all the leases shall be furnished.

In this connection, it is brought to your notice that the above violation constitutes an offence punishable under Rule-62 of MCDR, 2017. inability to comply the provisions of rule 45(5) (7) of MCDR, 2017 is also liable for suspension of mining operations under rule 45(5)(7)aaa¹/₄a¹/₂¹/₄i¹/₂ of MCDR, 2017
- 03. You are advised to rectify the above violations immediately and intimate the position to this office within 45 (Forty Five) days from the date of issue of this letter.
