Sub: Violation of provisions of Mineral Conservation and Development Rules, 2017 in respect of Sultanpur Thanda Limestone Mine of M/s NCL Industries Limited over an extent of 42.83 ha situated in Pedavedu Village, Matampally Mandal, Suryapeta District of Telangana State.

Sir,

The following provisions of Mineral Conservation and Development Rules, 2017 (MCDR, 2017) were found violated in your above mine during inspection of the mine on 20.01.2022 by the undersigned accompanied by Sri Mahipal Reddy, Manager (Mines).

- accounting for single lease, therefore details of all the leases shall be furnished.
- iv. Part-V, item no.3: Discrepancies in the Resources and Reserves submitted in the Annual return and that of approved Mining Plan areas below: Reserves (111) of 15 is furnished instead of 2,57,59,106 Tonnes, (25.75 million Tonnes), and Resources(211) 14 is furnished instead of 1,84,86,889 Tonnes, (18.48 million Tonnes).
- 02. In this connection, it is brought to your notice that the above violation constitutes an offence punishable under Rule-62 of MCDR, 2017. Besides, inability to comply the provisions of rule 11(1) and 45(5)(7) of MCDR, 2017 is also liable for suspension of mining operations under rule 11(2) and 45(5)(7)(a)(i) of MCDR, 2017
- 03. You are advised to rectify the above violations immediately and intimate the position to this office within 45 (Forty Five) days from the date of issue of this letter.
