

Sub: Violation of provisions of Mineral Conservation and Development Rules, 2017 in respect of Sadanandapuram Manganese Mine (40APR20028) over an extent of 56.838 ha in Sadanandapuram Village, Gurla Mandal, Vizianagaram District, Andhra Pradesh.

Sir,

The following provisions of Mineral Conservation and Development Rules, 2017 (MCDR, 2017) were found violated in your above mine during the inspection on 08.03.2021 in the presence of Shri. A.Vishwanath Rao Naidu, Mine Manager.

Rule No.	Nature of Violations observed
45(7)	Following deficiencies were observed in the Annual Returns submitted for the year 2019-20: i. In the cost per tonne calculation, the details of DMF and NMET are not matching with the amount submitted in the Part-III, S1.No.5.
	ii. Depreciation cost is not considered for the cost per tonne calculation in Part-VII.
	iii. Total quantity of overburden removed is not submitted in Part-V, Sl.No. 4.2 (C).

02. In this connection, it is brought to your notice that the above violations constitute an offence punishable under rule 62 of MCDR, 2017. Further, inability to comply the provision of Rule 45(7) is liable for suspension of mining operations under 45(7) (a) (i) of MCDR, 2017.

03. You are advised to rectify the above violations immediately and intimate the position to this office within 45 (Forty Five) days from the date of issue of this letter.
