विषय Sub: Violation of provisions of Mineral Conservation & Development Rules, 2017 in respect of your Barwana Limestone Mine over an area of 2.90 ha located near Village-Mandoli, Tehsil-Sangraha, District-Sirmour in Himachal Pradesh


महोदय Sir,

The following provisions of the Mineral Conservation & Development Rules, 2017 were found violated in your above mine during the inspection made by the undersigned on 15.12.2021 in the presence of Shri Narayan Singh Rana, Mining Engineer

RULE NO.	NATURE OF VIOLATION OBSERVED
11(1)	Mining Operation were not carried out in accordance with the mining plan approved vide letter No. 614(2)/MS-B-216/12-DDN, dated 01-02-2017 to the following extent: 1. As per proposal during the year 2020-21, it was proposed to develop an intermediate bench of two meters height at 1453 mRL but the same has not been developed. Further it was observed that bench height of five meters were not maintained at places as per proposals.
26(2)	The holder of mining lease shall submit to the competent authority a yearly report as per the format specified by the Indian Bureau of Mines, before 1 st day of July every year setting forth the extent of protective and rehabilitative works carried out as envisaged in the approved mine closure plan, and if there is any deviation, reasons thereof: On perusal of office records it is observed that yearly report for the year 2020-21 has not been submitted to the competent authority by the holder of the lease in the prescribed in this office till date.
33	The holder of a mining lease shall, on or before the 30 th day of June every year submit to the authorized officer a digital copy along with a print copy of the surface geological plans and sections maintained under Rule 32. However, the lessee has not submitted the copies of the plans and sections as per Rule 32 for the year 2019-20
55	Every holder of mining lease shall employ a part time Geologist in the mine. But geologist has not been appointed in the Mine.


- In this connection, it is brought to your notice that the violation of rules 11, 26 & 33 constitute an offence punishable under Rule 62(1) and rule 55 constitute an offence punishable under Rule 62(2) prescribed at Schedule III of MCDR Amendment Rules 2021.
- Mining operations can also be suspended as per rule 11(2) in case of non compliance of rules 11(1) of MCDR.
- You are advised to rectify the above violations immediately and intimate the compliance position to this office within 45 days from date of issue of this letter
