Violation of provisions of Mineral Conservation & Development Rules, 2017 in respect of your Banour Limestone Mine, Mining Lease over an area of 4.75 ha located near Village -Banour Tehsil- Paonta Sahib

महोदय Sir,

The following provisions of the Mineral Conservation & Development Rules, 2017 were found violated in your above mine during the inspection made by the undersigned on 30.12.2021 in the presence of Mr. K.N Pant Mine Manager.

RULE NO.	NATURE OF VIOLATION OBSERVED
11(1)	Mining Operation has not been carried out in accordance with the approved Review and Updation of Mining Plan of vide letter no. 614(2)/MP-B-243/14-DDN dated 31-03-2020 to the following extent:  1. As per proposals approved vide above referred letter, you were suppose to carry out exploration by means of 5 boreholes with 164 metrage in 2021-22, but during inspection it was found that the said exploration has not been carried out and even not yet started till date. This may lead to further violation of rule 12(4) of MCDR 2017 which binds the lessee to undertake detailed exploration (G1 level) over the entire potentially mineralized area under the mining lease within a period of five years from the date of commencement of these rules i.e, upto 26.03.2022.

- 2. In this connection, it is brought to your notice that the violation of rule 11 an offence punishable under Rule 62(1) of MCDR Amendment Rules 2021.
- Mining operation can also be suspended as per rule 11(2) in case of non-compliance of any Rule/sub-rule of 11 of
- 4. You are advised to rectify the above violations immediately and intimate the compliance position to this office within 45 days from date of issue of this letter.
