The following provision of Mineral Conservation & Development Rules, 2017 were found violated in your above mine during the inspection on 07/02/2019 , by the undersigned in presence of Shri A.P.Gaonkar, Lessee.

Rule	Nature of Violation observed
27(1)	The Bank Guarante is expired on 31.03.2016 and you have not submitted valid Bank Guarante after 31.03.2016. A financial assurance as per MCDR 2017 should be submitted.
35(2)	Every holder of a mining lease shall submit high resolution satellite images obtained from CARTOSAT-2 satellite LISS-IV sensor on the scale of cadastral map, as on the 31st day of March for that financial year, covering the mining lease and an area of two kilometres. from the lease boundary, to the Regional Controller or the authorised officer of the Indian Bureau of Mines before 1 st day of July. Lessee has not submitted the said map so far.
45(5) (b) and (c)	Lessee has not submitted monthly returns from May 2016 onwards and annual returns from 2013-14 onwards.
55(1) (3)(iv)	The Mining Engineer and Geologist required under the said rule is not appointed by the lessee.

02. In this connection, it is brought to your notice that the above violation constitutes an offence, punishable under Rule 62 of MCDR, 2017.

03. The mining operations can be suspended under Rule 11(2), if compliance of MCD Rules 2017 is not found satisfactory.

04. You are advised to rectify the above violation immediately and intimate the position to this office within 45 (Fourty five) days from the date of issue of this letter.
