Violation of provisions of MCDR 2017 in respect of your Kairulabad Limestone Mine over an area of 24.63.5 Ha in Kairulabad Village, Ariyalur Taluk & District.

The following provision of the Mineral Conservation and Development Rules, 2017, was found violated in your above mine during the inspection on 18/11/2020 by the undersigned in the presence of Mr Srihari Rao S (Mine Engineer) & Mr G S S Naidu Adabala (Geologist) & the same was communicated to you vide Violation Letter of even number dated 12.01.2020:

- 02. In this connection, it is brought to your notice that the above violations constitute an offence punishable under Rule 62 of Mineral Conservations and Development Rules, 2017.
- 03. The mining operation can be suspended under Rule 11(2), if the compliance of the rule is not found satisfactory.
- O4. You are, therefore, directed to show cause within a period of 30 days from the date of issue of this letter, as to why you should not be prosecuted for the above offences.
- 05. Please note that no further notice will be given to you in this regard.
