Sir,

On the examination of this office records, following provisions of Mineral Conservation & Development (Amendment) Rules, 2021 are violated in respect of your above referred mine.

- 2. It is brought out to your kind notice that, Mineral Conservation & Development (Amendment) Rules, 2021 was notified vide G.S.R. no 780 (E) dated 3/11/2021 and as per Schedule II of said Rules, in case of violation under Rule 45, the lessee shall pay Rs. 10,000/- per day after due date of submission of return till rectification of violation. Accordingly, you are advised to pay Rs.50000/- (Fifty thousand only) in Bharat Kosh, in favor of Controller Name: Mines, PAO Name: PAO, Indian Bureau of Mines, Nagpur, PAO Code: 037307 within thirty days from the date of issue of this letter. Receipt has to be sent to this office.
- 3. It is further brought to your notice that, the violation of said rule constitutes an offence punishable under Rule 62 of Mineral Conservation & Development (Amendment) Rules, 2021.

4. You are, therefore, directed to **show-cause** within a period of **30 days** from the date of issue of this letter, as to why mining operations in your above mine should not be suspended in accordance to rule 45(7) of Mineral Conservation & Development (Amendment) Rules, 2021.
