Sub: Violation of provisions of Mineral Conservation and Development Rules,2017 in respect of your Sultanpur Thanda Limestone Mine (38APR14039) over an area of 42.83 Ha in Pedaveedu Village, Mattampalli Mandal, Suryapet district, Telangana.

Sir,

The following provisions of Mineral Conservation and Development Rules, 2017 were found violated in your above mine during inspection on 10.03.2021 in the presence of Sri.G.S. Subba Rao, DGM(Mines) and Sri. Mahipal Reddy, Manager (Mines).

Rule No.	Nature of Violations observed
11 (1)	No holder of a mining lease shall commence or carry out mining Operations in any area except in accordance with the mining plan approved, modified or reviewed by the Indian Bureau of Mines. Your Review of Mining Plan document was approved vide letter No. AP/NLG/MP/LST-31/HYD dated 27/02/2017 and following deviation have been observed: It was proposed to carry out exploration in the plan period by drilling 19 boreholes in 2019-20, but during inspection it was observed that only 03 Nos. of boreholes were drilled against the approved proposal.
55(1)	For the purpose of carrying out reconnaissance, prospecting or mining operations in accordance with these rules – every holder of a mining lease shall employ, in case of- (i) category ‘A’ mines, a whole-time geologist. During inspection it was noticed that “Geologist” was not appointed as per the Rule 55 (1) 3.(i) of MCDR 2017.

02. In this connection, it is brought to your notice that the above violations constitute an offence punishable under rule 62 of MCDR, 2017. Further, inability to comply the provision of Rule 11(1) is liable for suspension of mining operations under 11(2) of MCDR, 2017.

03. You are advised to rectify the above violations immediately and intimate the position to this office within 45 (Forty Five) days from the date of issue of this letter.
