Sir,

On the examination of this office records, following provisions of Mineral Conservation & Development (Amendment) Rules, 2021 are violated in respect of your above referred mine.

It is brought out to your kind notice that, Mineral Conservation & Development (Amendment) Rules, 2021 was notified vide G.S.R. no 780 (E) dated 3/11/2021 and as per Schedule II of said Rules, in case of violation under Rule 45, the lessee shall pay Rs. 10,000/- per day after due date of submission of return till rectification of violation. Accordingly, you are advised to pay Rs.40000/- (Forty thousand only) in Bharat Kosh, in favor of Controller Name: Mines, PAO Name: PAO, Indian Bureau of Mines, Nagpur, PAO Code: 037307 within thirty days from the date of issue of this letter. Copy of receipt has to be sent to this office.
- 3. It is further brought to your notice that, the violation of said rule constitutes an offence punishable under Rule 62 of Mineral Conservation & Development (Amendment) Rules, 2021.

You are, therefore, directed to show-cause within a period of 30 days from the date of issue of this letter, as to why mining operations in your above mine should not be suspended in accordance to rule 45(7) of Mineral Conservation & Development (Amendment) Rules, 2021.
