विषय: Violation of provision of Mineral Conservation and development rule 2017 in respect of your Lakhri Limestone Mine in Bundi district of Rajasthan State.

महोदय,

The following provision of Mineral Conservation and Development Rules, 2017 (hereinafter referred as MCDR, 2017) were found violated in your above said mine during inspection on 15/11/2021 and 16/11/2021 by undersign in presence of Sri Manish Kumar Upadhyay , Mine Manager and Sri Deepal Gorasia, Mining Engineer and Sri N K Pandey, Geologist of your mine .

Rule	Status and extent of violation
11(1)	<p>Mining operations have not been carried out in accordance to Review of Mining Plan approved on 22/01/2020 and Modified Mining Plan approved on 08/12/2020 to the extent given below for the year 2020-21:</p> <p>(1) A total of 42 exploratory bore holes with 1867 meters of drilling were carried out against the target of 50 exploratory bore holes with 1900 meters of drilling. Resulting shortfall in number of bore holes as well as in drilling meterage.</p> <p>(2) (1) The Ore to Overburden ratio (stripping ratio) was achieved 1:1.48 ton/ton against the target of 1:1.23 ton/ton.</p> <p>(3) As per approved document dated 08/12/2020, an area of 168.74 hectare has been proposed to degrade under excavation, however, as per submitted annual return an area of 221.353 hectare has been furnished under opencast working. Similarly, as per mentioned approved document, a total of 314.23 hectare area has been proposed to degrade, however, as per submitted annual return an area of 444.723 hectare has been degraded.</p> <p>(4) As per approved document dated 08/12/2020, plantation on waste land has been proposed over 7.0 hectare area, however, as per PMCP report plantation has been carried out over 6.0 hectare area only.</p>
45(7)	<p>On examination of online filed annual return for the year 2020-21, following discrepancies have been observed:</p> <p>(1) Part IIA: Value of fixed asset of Rs. 559139938.00 has been furnished; however, depreciation during the year has been furnished as '0'.</p> <p>(2) Part III: As per return a total of Rs. 2450365.00 has been paid for royalty payment. Accordingly, payment towards DMF should be Rs. 24990528.00 (30% of royalty) as per notified DMF rules. However, under mentioned part, the amount of royalty has been furnished as Rs. 37069283.00. Further, the amount paid towards NMET has not shown in prescribed Coolum for central Govt.</p>

(3) Part VII (cost of production):

- a) Mining cost of Rs. 167.27.00 has been furnished, whereas the Mining cost as per expenses furnished in annual return is Rs. 77.42 per tones.
- b) As per return a total of Rs. 106965451.00 has been furnished as overhead cost, however, overhead cost has been furnished as '0' in cost of production.

It shows that you have submitted incomplete or wrong or false information in annual return for the year 2020-21.

02. इस संदर्भ में आपका ध्यान आकर्षित किया जाता है कि उपरोक्त नियमों का उल्लंघन खनिज संरक्षण एवं विकास नियमावली, 2017 के नियम 62 के अंतर्गत दंडनीय अपराध है एवं उपरोक्त नियमों का उल्लंघन की अनुपालना नहीं होने पर खनिज संरक्षण एवं विकास नियमावली, 2017 के अंतर्गत :

- (क) आपकी खदान की सारी संक्रियाएं बंद की जा सकती है।
- (ख) आपके विरुद्ध अभियोग दायर किया जा सकता है।
- (ग) राज्य सरकार को खनन पट्टे की समप्ति की सिफारिश।

03. इस संबंध में आपका ध्यान आकर्षित किया जाता है कि नियम 45(7) के उल्लंघन के लिए खनिज संरक्षण एवं विकास (संशोधन) नियम 2021 की अनुसूची-2 के प्रावधान लागू होंगे।

04. अतः आपको सलाह दी जाती है कि आप उपरोक्त उल्लंघनों का अतिशीघ्र सुधार करें एवं इसके सुधार की स्थिति की सूचना इस पत्र के जारी होने की दिनांक से 45 (पैंतालिस) दिनों के भीतर इस कार्यालय को सूचित करें।
