Sub :Violation of provisions of Mineral Conservation & Development Rules, 2017 in respect of your Chikkashellikere Limestone Mine (M.L.No-2262), over an extent of 8.09 Ha. Situated in Chikkashellikere village, Bagalkot District of Karnataka State.

Sir,

The following provision of Mineral Conservation & Development Rules, 2017 were found violated in your above mine during the inspection on 08/03/2019 , by the undersigned in presence of Shri Burali, Manager (Admin).

Rule	Nature of Violation observed
11(1)	a) In the approved Modification in the approved mining plan dated 21.08.2018, there was a proposal to produce 590000 tons of limestone in the year 2018-19. During inspection it was observed that no such production was carried out. b) There was a proposal to plant 170 saplings in the year 2018-19,.However, on the day of inspection it was observed that no such plantation was made.
26(2)	An yearly report before 1st July of every year setting forth the extent of protective and rehabilitation work carried out as envisaged in the approved progressive mine closure plan has not been submitted for the year 2017-18 so far.
28	The mine is not working from September 2018 onwards but Notice of temporary discontinuance of work in the form E is not submitted so far.
45(5) (c)	Annual returns for the year 2017-18 is not submitted so far .
55(1)(3) (iv)	The Mining Engineer and Geologist required under the said rule are not appointed by the lessee.

02. In this connection, it is brought to your notice that the above violation constitutes an offence, punishable under Rule 62 of MCDR, 2017.

03. The mining operations can be suspended under Rule 11(2), if compliance of MCD Rules 2017 is not found satisfactory.

04. You are advised to rectify the above violation immediately and intimate the position to this office within 45 (Fourty five) days from the date of issue of this letter.
