महोदय Sir,

The following provisions of the Mineral Conservation & Development Rules, 2017 were found violated in your above mine during the inspection made by the undersigned on 15.02.2021 in the presence of Shri Pankaj Nayan , Mines Manager.

RULE NO.	NATURE OF VIOLATION OBSERVED
11(1)	Mining Operation were not carried out in accordance with the approved Modified of Mining Plan vide letter no. 614(2)-MS-A-138/2003-DDN dated 09-02-2018 to the following extent: (i) As per proposal on page -23 during the year 2020-21, it was proposed to carry out 06 bore holes but during the inspection it was observed no such boreholes drilling carried out during the year 2020-21.

2. In this connection, it is brought to your kind notice that the above violations constitute an offence punishable under Rule 62 of MCDR 2017.
3. Mining operations can be suspended as per rule 11(2) in case of non compliance of rules 11(1) and any other relevant rules of MCDR 2017 as these rules ensures systematic scientific and responsible mining.
4. You are advised to rectify the above violations immediately and intimate the compliance position to this office within 45 days from the date of issue of this letter.
