

Violation of provisions of Mineral Conservation & Development Rules, 2017 in respect of your

Manal Limestone Mine, Mining Lease over an area of 172.30 ha located near Village-Manal, Tehsil-

Paonta Sahib, District-Sirmour in Himachal Pradesh-Reg

महोदय Sir,

The following provisions of the Mineral Conservation & Development Rules, 2017 activities during 2019-20 up to 31.03.2020 were found violated in your above mine during the inspection made by the undersigned on 13.03.2021 in the presence of Shri P.K Sinha, Mine manager and Shri Kumbha Ram, Mining Engineer.

RULE NO.	NATURE OF VIOLATION OBSERVED
11(1)	<ul> <li>Mining Operation were not carried out in accordance with the approved Review and Updation of Mining Plan vide letter no. 614(2)/MS-A-182/09-DDN dated 11-07-2018 to the following extent: <ol> <li>As per proposal on page -29 during the year 2019-20, it was proposed to carry out 06 bore holes with total 431.02 meterage but during the inspection it was observed no exploration was carried out during the year 2019-20.</li> <li>As per PMCP proposal on page -65 during the year 2019-20, it was proposed to construct garland drain along top periphery of the existing pits of 240m and catch drains along both sides of haul roads of 200m but during the inspection it was observed no such construction was carried out during the year 2019-20.</li> </ol> </li> </ul>
33	The holder of a mining lease shall, on or before the 30 <sup>th</sup> day of June every year submit to the authorized officer a digital copy along with a print copy of the surface geological plans and sections maintained under Rule 32. However, the lessee has not submitted the copies of the plans and sections as per Rule 32 for the year 2019-20
45(7)	The holder of mining lease has submitted incomplete and/or inconsistent or false information in annual return:  1. Reported cost of production is given Rs. 284 per Tonnes which appears to be very high.

In this connection, it is brought to your kind notice that the above violations constitute an offence punishable under Rule 62 of MCDR 2017.

Mining operations can be suspended as per rule 11(2) in case of non compliance of rules 11(1) and any other relevant rules of MCDR 2017 as these rules ensures systematic scientific and responsible mining.

Advise the State Government to order suspension of all mining operations in the mines as per provision of Rule 45(7), in case if it is found that the holder of a mining lease has submitted incomplete or wrong or false information in statutory returns or fails to submit such return within the date specified under Rule 45.

You are advised to rectify the above violations immediately and intimate the compliance position to this office within 45 days from date of issue of this letter.
