The following provisions of Mineral Conservation and Development Rules, 1988 were found violated in your above mine during the inspection by undersigned on 15/03/2016 in the presence of Shri S.K.Sinha,

Rule 45(5)(a)	According to this rule the owner, agent, mining engineer or manager of every mine, shall submit to the Regional Controller of Mines returns in respect of each mine, in the following manner, namely:  a monthly return which shall be submitted before the 10th of every month in respect of preceding month in the prescribed Form  Monthly returns for September 2015 and onwards have not been received in this office till date.
Rule 46	According to this rule the owner of the mine shall within fifteen days from the date of appointment/termination of agent of the mine give a notice in form I to the Controller General, Controller on mines and Regional controller of mines.  Notices of Termination of agent Sh. S.K.Tiwari & appointment of Sh. S.K.Sinha as agent of the mine along with their consents have not received in this office.

- In this connection it is brought to your notice that the above violations constitute an offence 2. punishable under rule 58 of MCDR, 1988.
- 3. It may be noted that wrong/false or non-submission of returns within the date specified, attracts provisions of Rule 45(7) according to which the Regional Controller of Mines may,-
- (a) Order suspension of all mining operations.
- (b) Initiate prosecution under these rules;
- (c) Recommend termination of the mining lease,
- 4. You are advised to rectify the above violations immediately and intimate the position to this office within 45 (forty-five) days from the date of issue of this letter.
