Sub: Violation of provisions of Mineral Conservation and Development Rules, 2017 (MCDR, 2017) in respect of your Navage & Hangirge (DBS) Bauxite Mine, over 118.77 Ha., Situated in District of Belgaum district of Karnataka State.

Sir,

The following provisions of Mineral Conservation and Development Rules'2017 were found violated in your above said mine during inspection on **26.11.2018** by the undersigned in the presence of Mr. K. Venu, your representative and Mr. B.A. Patil, TQP and violation letter of even no., dtd. **06.12.2018** was issued for below mentioned rules of MCDR,2017.

Rule No.	Nature of Violation observed
45(5)(c)	An Annual Return ought to be submitted before the 1 st day of July each year for the preceding financial year, has not been submitted to this office so far for the year 2016-17 and 2017-18.
45(7)	In submitted Monthly return of October'2018, Closing stock of ROM ore at mine-head (Bauxite) reported as Nil. Whereas about 20,000 te of ROM ore stock are observed available at the mine head.

02. You were advised to rectify the above violations immediately and intimate the position to this office within 45 (forty-five) days from the date of issue of aforesaid letter. However, no response has been received so far from your side in respect of compliance of above violations.
03. In this connection, it is brought to your notice that the above violations constitute an offence punishable under Rule 62 of MCDR, 2017.
04. Action according to Rule 45(7) of MCDR, 2017 can be initiated, if compliance of Rule 45 is not found satisfactory.
05. You are therefore directed to show cause within a period of **30 (thirty) days** from the date of issue of this letter as to why you should not be prosecuted for the above offence and/or the mining operations should not be recommended for suspension in accordance to Rule 45(7) of MCDR, 2017.
06. Please note that no further notice will be given to you in this regard.
