The following provision of the Mineral Conservation and Development Rules, 2017 was found violated in your above mine during the inspection on **13.03.2019** by undersigned in presence of the mine official Shri V. Narayan Prasad, Agent and other officials of the mines.

11(1)	<ul> <li>As per Scheme of Mining approved vide letter No. MSH/Mech-78/ (MAH) (Goa)/2014-15 dated 18.05.2015, the following back filling proposals in the worked out pit were made.</li> <li>(i) In 2017-18 backfilling by 3,44,120 tonnes of material over an area of 1.9 Ha at the level between -4 to +14 mRL.</li> <li>(ii) In 2018-19 backfilling by 3,20,880 tonnes of material over an area of 2.12 Ha at the level between +8 to +20 mRL. However, during the inspection it was observed that backfilling progress is not observed as per the proposals.</li> </ul>

- 02. In this connection, it is brought to your notice that the above violations constitute an offence punishable under Rule 62 of Mineral Conservations and Development Rules, 2017.
- 03. The mining operations can be suspended under rule 11(2) if compliance of rule 11(1) is not found satisfactory.
- 04. You are advised to rectify the above violations immediately and intimate the position to this office within 45 (Forty Five) days from the date of issue of this letter.
