45(7)	 Following deficiencies were observed in the annual returns submitted for the year 2017-18. a) Details of location of the mine and address details are not given. b) As on date lease is with original lessee only. However date of lease transfer is mentioned as 23.12.2008 c) Value of fixed asset is shown as zero. Whereas net closing balance is shown as Rs-12300704. - 04. You are advised to rectify the above violation immediately and intimate the position to this office within 45 (Fourty five) days from the date of issue of this letter.
