विषय : Violation of provisions of Mineral Conservation & Development Rules, 2017 in respect of your Sodpura Wollastonite Mine (Lease area 24.865 Ha.) in Pali District of Rajasthan State.
महोदय,

The following provisions of the Mineral Conservation and Development Rules, 2017 were found violated in your above mine during the inspection made on 17.12.2018 by the undersigned in presence of Sh. Shri Prabhat Dagliya DGM(Geology):

Rule No.	Nature of violation observed in detail
Rule 11(1)	The mining operations are carried out in violation of following provisions of approved Modified Mining Plan (Approved on 18.10.2016) for the year 2017-18: 1) Exploration was proposed by two trail pits having dimension 6mX5mX4m near deposit 1 but same has not been carried out.
35(2)	Every holder of a mining lease shall monitor his mining and allied activities as per the notified template of star rating in the format prescribed in this behalf by the Indian Bureau of Mines from time to time, and shall submit online its self-assessment report before the 1 st day of July every year for the previous financial year, alongwith the soft copy (in the standard format), of high resolution satellite images obtained from CARTOSAT-2 satellite LISS-IV sensor on the scale of cadastral map, as on the 31 st day of March for that financial year, covering the mining lease and an area of two kilometers, from the lease boundary, to the Regional Controller or the authorized officer of the Indian Bureau of Mines. But, it has been observed that you have submitted online star rating template only and till date you have not submitted the satellite images as stipulated under the rule.
Rule 45(7)	In annual return 2017-18 following discrepancies were observed: 1) Information in Part I (Lease area utilization as the the end of year)- The details given are not matching the figure given in Financial Assurance Table in PMCP chapter of the approved modified mining plan(approved on 18.10.2016). 2) Under item 2 of Part III royalty amount has been shown as Rs. 100000 whereas production and dispatch shown zero under item 1 & 2 of Part VI.

02. In this connection, it is brought to your notice that the above violations constitute an offence punishable under Rule 62 of MCDR, 2017 and in case of non compliance of the above rules following action may be initiated under MCDR, 2017:

- Mining operations may be suspended under rule 11(2) of MCDR, 2017.
- Prosecution may be launched against you.

03. You are advised to rectify the above violations immediately and intimate the compliance to this office on letter pad signed by the owner within 45 (forty-five) days from the date of issue of this letter.
