
महोदय Sir,

The following provisions of the Mineral Conservation & Development Rules, 2017 (MCDR, 2017) were found violated in your above mine during the MCDR inspection made by the undersigned on 03.11.2020 in the presence of Shri Tapender Singh, Fauji representative of lessee which was communicated on 22-12-2021.

| RULE NO. | NATURE OF VIOLATION OBSERVED |

| 11(4) | The holder of a mining lease shall submit the mining plan to the competent authority for review at least on hundred and eighty days before the expiry of five years period for which it was approved on the last occasion, for mining operations for a period of five subsequent years. Modified Mining plan with PMCP was approved vide letter no. 614(2)/MP-B-193/11-DDN dated 15-03-2019 but lessee has not submitted the Review & Updation of Mining Plan with PMCP till date. |
| 33 | The holder of a mining lease shall, on or before the 30 th day of June every year submit to the authorized officer a digital copy along with a print copy of the surface geological plans and sections maintained under rule 32. However, the lessee has not submitted the copies of the plans and sections as per rule for the year 2019-20. |
| 55 | Every holder of mining lease shall employ a geologist and a mining engineer in the mine. But geologist and mining engineer have not been appointed in the mine. |
| 45(7) | The holder of a mining lease has submitted incomplete or wrong information in Annual Return for the Year 2019-20. 1. Part-VII Cost of Production- Cost of production of Limestone is very high. |

- On perusal of your reply of letter No.JMM/BARWAS/IBM-VIOLATION/2020 dated 05.02.2021 received by this office dated 16-02-2021, it is found that compliance of rules 33 & part of 55 has been made whereas compliance for violation of Rule 11(4), 45(7) & part of 55 is not found complied. Thus violation of rule 11(4), 45(7) & reaming part of 55 of MCDR, 2017 to the extent pertaining to employment of geologist still persists.
- In this connection, it is brought to your kind notice that the above violations constitute an offence punishable under Rule 62 of MCDR 2017.
- Mining operations can be suspended as per rule 11(2) in case of non compliance of rule 11(1), 11(4) and any other relevant rules of MCDR 2017 as these rules ensures systematic scientific and responsible mining.
- Advise the State Government to order suspension of all mining operations in the mines as per provision of Rule 45(7), in case if it is found that the holder of a mining lease, has submitted incomplete or wrong or false information in statutory returns or fails to submit such return within the date specified under Rule 45.
- You are advised to rectify the above violations immediately and intimate the compliance position to this office within 30 days from date of issue of this letter.
- You are therefore directed to show cause within a period of thirty (30) days from the date of issue of this letter, as to why you should not be prosecuted and / or why the mining operation should not be suspended under relevant statutory provisions and/or why not any other appropriate action can be initiated in accordance with rules and/or any competent orders/directives.
- Please note that no further notice will be given to you in this regard.
