विषय Sub: Show Cause Notice in respect of violation of provisions of Mineral Conservation & Development Rules, 2017 in respect of your Banour Limestone Mine, Mining Lease over an area of 4.75 ha located near Village: Banour Tehsil: Paonta Sahib, District-Sirmour, H.P State.

महोदय Sir,

The following provisions of the Mineral Conservation & Development Rules, 2017 (MCDR, 2017) were found violated in your above mine during the MCDR inspection made by the undersigned on 14.01.2021 in the presence of Shri R C Malik, Mine Manger which was communicated on 01-02-2021.


RULE NO.	NATURE OF VIOLATION OBSERVED
11(1)	Mining operation were not carried out in accordance with the approved modified mining plan with PMCP vide letter no 614(2)/76- DDN dated 10.08.2015 to the following extent: (i) Chapter -2 page no 30 the height of benches in limestone was proposed 6 meter but during the inspection benches height was found more than 6 meter which is not maintained as per proposals.
33	The holder of a mining lease shall, on or before the 30 <sup>th</sup> day of June every year submit to the authorized officer a digital copy along with a print copy of the surface geological plans and sections maintained under rule 32. However, the lessee has not submitted the copies of the plans and sections as per rule for the year 2019-20.
45(7)	The holder of a mining lease has submitted incomplete or wrong information as follows: Annual Returns for the year 2019-20. 1. Part- IV Consumption of Explosive-Quantity of explosive consumption is very low which is not correct in r/o of production quantity. 2. Reported Ex mine Price is not correct of year 2019-20. 3. Part-VII Cost of Production –Reported production cost of Limestone is 490/Tonnes which is very high. Monthly Returns: 1. Part-II details of consignee including registration no. shall be furnished in the returns.

- On perusal of your reply of letter No.Nil dated 10-03-2021 received by this office dated 17-03-2021, it is found that compliance of rules 11(1), 33 & partly of 45(7) i.e. annual returns was made whereas compliance for violation of Rule 45(7) i.e. monthly returns part not found complied. Thus violation of rule 45(7) of MCDR, 2017 in monthly returns still persists.
- In this connection, it is brought to your kind notice that the above violations constitute an offence punishable under Rule 62 of MCDR 2017.
- Advise the State Government to order suspension of all mining operations in the mines as per provision of Rule 45(7), in case if it is found that the holder of a mining lease, has submitted incomplete or wrong or false information in statutory returns or fails to submit such return within the date specified under Rule 45.
- You are advised to rectify the above violations immediately and intimate the compliance position to this office within 30 days from date of issue of this letter.
- You are therefore directed to show cause within a period of thirty (30) days from the date of issue of this letter, as to why you should not be prosecuted and / or why the mining operation should not be suspended under relevant statutory provisions and/or why not any other appropriate action can be initiated in accordance with rules and/or any competent orders/directives.
