The following provision of Mineral Conservation & Development Rules, 1988 was found violated during the inspection of your above mine on 16/12/2015 FN by the undersigned.

16	It was observed during inspection that non-saleable material/top soil/intercalated waste stacked
	separately but it was mixed & not properly stacked/dumped on earmarked ground in west middle of lease area.

42(1)©(i)	A full time Mining Engineer and Geologist have not been employed for the purpose of carrying out mining operations in accordance with these rules.
45(5)(b)	An annual returns for the year 13-14 & 14-15 which shall be submitted before the 1 st July of the preceding financial year in the prescribed form-H-8, has not been submitted to the Regional Controller of Mines, Indian Bureau of Mines Goa so far. The annual production reported in AR 2012-13 is not matching with monthly return submitted to this office.
63	A Self-Appraisal Report to be submitted by Owner of the mine under Rule 63 of MCDR, 1988 stating extent of implementation of Approved Mining Plan/Scheme of Mining during the year of 2012-13 along with supporting plans/sections, representative photographs in hard as well as soft copy.

- 02. In this connection, it is brought to your notice that the above violation constitutes an offence, punishable under Rule 58 of MCDR, 1988.
- 03. You are advised to rectify the above violation immediately and intimate the position to this office within 45 (forty five) days from the date of issue of this letter.
