CHAPTER NO.1: GENERAL INFORMATION:

4. At para 1.1: Name of the lease area is not mentioned, the same should be mentioned.
5. At para 1.1: The name of the village in which the mining lease situated to be mentioned as venkatapuram.
6. The five year of block period and category of the mine mentioned are incorrect. The same should be corrected.
7. At para 1.1.1: The Initial lease grant details mentioned are incorrect. The same may be furnished correctly.
8. At Para 1.2: The details regarding list of mining leases held by Shri Pedda konda Reddy is already held / applied area should be indicated.
9. At para 1.3.1: The details pertaining to earlier approved Mining Plan mentioned are incorrect. The same may be corrected and submitted.
10. At para 1.3.4.2: Annexure may be enclosed for SPCB approvals.
11. At para 1.3.5 : The topo sheet number to be verified and correct it.
12. Kml files in respect of boundary pillars, land put to use and proposal should be submitted separately.
13. At para 1.3.7. Qualified Person Details as per M(OAHCEM)CR, 2016: A copy of PAN of Qualified Person shall be submitted as Annexure.
14. Instead of leaving blank any Column /Row, NA or any information may be given appropriately.

CHAPTER NO.2: GEOLOGY AND EXPLORATION

15. At para, 2.2.1.1: The details of Geological Mapping are not furnished properly. The same should be furnished correctly.
16. Para 2.2.1.5: The details of trail pits are furnished instead of existing pit details. The same may be furnished along with their dimension to be mentioned in the text.
17. At para 2.2.1.10: The Chemical analysis of the samples not furnished. The same should be furnished and enclosed with annexure number.
18. At para 2.2.1.13.: The bulk density furnished is incorrect. The same should be corrected and furnished.

19. At Para 2.2.1.14: The details pertaining to area proved as non-mineralized, area to be explored and total area covered under exploration are not furnished. The same should be furnished.
20. At para 2.2.2.1: All the details pertaining to geological mapping to be furnished properly.
21. At para 2.2.2.14: Area Covered under Exploration: All the required information under this column along with year of exploration to be submitted.
22. At para 2.2.5.: The details of future exploration proposal to be furnished.
23. At para 2.2.5.5.1: All the details pertaining to proposed boreholes to be furnished.

CHAPTER 4: MINING OPERATIONS

24. At para 4.2.2.1: The bench parameters are not furnished under this column. All details under this column should be furnished at relevant column.
25. At para, 4.2.2.2: Year wise Opencast Development: The details for 2022-23, 2023-24 & 2024-25 in respect of bulk density of overburden, top soil volume, over burden volume and over burden quantity (t) are not furnished. The same should be furnished at relevant places.
26. At para, 4.3: The details of Material Handling Summary is not furnished. The same should be furnished and annexures also be enclosed with serial numbering order.
27. At para 4.4.5.1. Excavator & loading equipment type shall be mentioned in the relevant column.
28. At para 4.4.5.3: The details of drilling details not furnished. The same should be furnished.

29. All the plans such as surface plan surface geological plan, conceptual plan etc to be submitted in the .KML or shape files with an attributes both existing & proposed.

CHAPTER 5: SUSTAINABLE MINING:

30. At para 5.1. Sustainable Mining and SDF Implementations in Compliance of Rule 35 of MCDR'2017 shall be submitted.

CHAPTER 6: PROGRESSIVE MINE CLOSURE PLAN:

31. At para 6.2.3.2: The year wise proposal for green belt is mentioned, but the proposed location is not mentioned properly. The same should be furnished.
32. At para 6.2.4.1: The details of cumulative work done (upto end of previous block of five years) are not given. The same should be given.

CHAPTER 9: IMPACT ASSESSMENT

33. At para 9.3.2.1: The table given for base / present status of the lease area, is not filled all the required columns / furnished. The same should be furnished properly in the table.

ANNEXURE

34. All the annexures must be numbered and enclosed serially.

PLANS / PLATES AND SECTIONS

35. Highest and lowest RL of topography may be verified.

36. The relevant Plans and sections should be signed with date by certified surveyor, qualified person, mines manager, mining engineer, and Geologist as per provision of Rule 34 of MCDR 2017.
37. Wind direction may be shown in wind rose diagram at the top right of the relevant plans. Further, colour code given for different features in plans and sections to be same.
38. All the plans and section should be signed by the Lessee.
39. Proposal period may be furnished in the title box in all the Plans and sections.
40. The photo-identity card of lessee is not visible- good quality of Photo Id card should be enclosed.
