Sub: Violation of provisions of MCDR, 1988 in respect of your Jinkalatippa Limestone Mine over an extent of 13.6 ha in Sy.nos 519/A1 and 644/2A of Malkapuram Village, Dhone Mandal, Kurnool district, AP.

Sir,

The following provisions of Mineral Conservation and Development Rules, 1988 were found violated in the above mine during inspection on 19.11.2016 by Sri M.Pratap Reddy, Asstt. Mining Geologist, of this Office accompanied by Sri Gopal Krishna Representative of the lessee.

Rule	Nature of Violation observed
24	It was reported that mine operation have been temporarily discontinued, but a notice in Form D-I has not been submitted.
45(5)(b)(viii)	Annual return in Form H-8 for the year for the Year 2015-16 has not been submitted to the Regional Controller of Mines, IBM, Secunderabad so far as required under this rule.

02. In this connection, it is brought to your notice that non compliance of violation of Rule 45(5)(b)( i) attract the provisions of Rule 45(7)(i)(a) of MCDR, 1988.

03. You are, therefore, directed to **show cause** within a period of 30 (thirty) days from the date of issue of this letter, as to why you should not be prosecuted for the above offence or mining operations suspended under Rule 45(7)(1)(a) of MCDR, 1988.

04. Please note that no further notice will be given to you in this regard
