Sub: Violation of provisions of MCDR, 1988 in respect of your Kalvatal-Kotapdu Limestone mine over an extent of 663.46 ha. in Kolimigundla Mandal, Kurnool District, Andhra Pradesh State.

The following provisions of Mineral Conservation and Development Rules, 1988 (amended in 2011) were found violated in the above mine during the inspection on 16.11.2016 by Sri M.Pratap Reddy Asst. Mining Geologist of this office in the presence of Sri G.Sriramulu DGM (Geology):

Rule No.	Nature of violation observed
13(1)	<p>Mining operations are not being carried out in accordance with the approved Scheme of Mining vide letter no. AP/KNL/MS/Lst-270/-SZ dated 4.9.2013 with proposal for the period upto 2017-18 to the extent indicated below:</p> <p>i. It is proposed to produce 32,12,500 T Limestone in the year 2015-16 but till date nil production is achieved.</p>

02. In this connection, it is brought to your notice that non compliance of violation of Rule 13(1) attract the provisions of Rule 13(2) of MCDR, 1988.

03. You are, therefore, directed to **show cause** within a period of 30 (thirty) days from the date of issue of this letter, as to why you should not be prosecuted for the above offence or mining operations suspended under Rule 13(2) of MCDR, 1988.

04. Please note that no further notice will be given to you in this regard
