Sub: Violation of provisions of Mineral Conservation and Development Rules, 2017 (MCDR, 2017) in respect of Pipalgaon Manganese Mine of M/s. Aditya Minerals pvt. Ltd., (20.36 ha) in Pipalgaon Village, Jainath Mandal, Adilabad dist., Telangana State.

Sir,

The following provisions of Mineral Conservation and Development Rules, 2017 were found violated in your above mine during the inspection on 10.3.2017 by Smt Ch.Suseela Assistant Mining Geologist of this office.

Rule No.	Nature of Violation
11(1)	The following mining operations were not carried out in accordance with the Scheme of Mining approved vide this office letter No. AP/ADB/MP/Mn-15/Hyd dated 18.2.2014 for the period 2013-14 to 2017-18 and thereby violating the provisions of MCDR, 2017. It was proposed to explore by 6 trial pits during the year 2015-16 against which only 3 trial pits have been made so far.
26(2)	The owner agent, manager or mining engineer shall submit to the Regional Controller of Mines, a yearly report before 1 <sup>st</sup> July of every year setting forth extent of protective and rehabilitative works carried out as envisaged in the approved mine closure plan, and if there is any deviation ,reasons thereof. But the same has not been submitted in this office for the year 2015-16.

02. In this connection, it is brought to your notice that the above said violation constitute an offence punishable under Rule-62 of MCDR, 2017 and inability to comply the provision of Rule 11(1) is also liable for suspension of mining operations under Rule 11(2) of MCDR,2017.

03. You are advised to rectify the above violation immediately and intimate the position to this office within 45(forty five) days from the date of issue of this letter.
