The following provisions of Mineral Conservation and Development Rules, 2017 were found violated in your above mine during the inspection on 8.3.2017 by Smt Ch.Suseela Assistant Mining Geologist of this office.

| 11(1) | The following mining operations were not carried out in accordance with the Scheme of Mining approved vide this office letter No. AP/KRM/MP/Lst-4/Hyd dated 1.4.2015 for the period 2014-15 to 2018-19 and thereby violating the provisions of MCDR, 2017 to the extent indicated below. It was proposed to construct Retaining wall and Garland drain all along the waste dump during the year 2014-15 against which no retaining wall and garland drain has been carried out so far. |

02. In this connection, it is brought to your notice that the above said violation constitute an offence punishable under Rule-62 of MCDR, 2017 and inability to comply the provision of Rule 11(1) is also liable for suspension of mining operations under Rule 11(2) of MCDR, 2017.

03. You are advised to rectify the above violation immediately and intimate the position to this office within 45(forty five) days from the date of issue of this letter.
