The following provisions of the Mineral Conservation and Development Rules, 2017 were found violated in your above mine during inspection on 14.03.2022 by the undersigned in the presence of Shri A.P. Moses, Mines Manager, Shri S.Mohan Kumar, Geologist, Shri Shiva Raj, Mining Engineer.

Rules	Nature of Violations observed
45(7)	The online Annual return for the year 2020-21 has been submitted by the Lessee; Following discrepancies are noted in the submitted copy as observed during site inspection. <b>Part-V.3</b> : The Reserves under 111 have not been given correctly.

02. The Mining operations and dispatches may be suspended and any action under subrule (7) of Rule 45 of MCDR 2017 read with MCDR (Amendment), 2021 may be initiated.

03. In this connection, it is again brought to your notice that this violation also constitutes an offence punishable under Rule 62 of MCDR (Amendment), 2021.

04. **You are therefore, directed to show cause within a period of thirty (30) days from the date of issue of this notice, as to why action under subrule (7) of Rule 45 and Rule 62 of MCDR 2017 read with MCDR (Amendment), 2021 shall not be taken against you.**

05. You are herewith given 30 days time for reply and rectification of the violation from the date of issue of this notice. The fine for the late submission of monthly return is to be made immediately as per Schedule-II of MCDR (Amendment) Rules, 2021. Please note that no further notice will be given to you in this regard.
