Subject: Violation of provisions of MCDR 2017 in respect of your Haraginadona Iron ore Mine, ML No. 2352 over an extent of 76.63 Ha located in Haraginadona Village, Ballari Taluk & District of Karnataka State.

Sir,

The following provisions of the Mineral Conservation and Development Rules, 2017 were found violated in your above mine during inspection on 15.03.2022 by the undersigned in the presence of Shri Vinodh S. J. Mines Manager & Mining Engineer.

Rules	Nature of Violations observed
11 (1)	<p>Modification to the approved Mining plan was approved by IBM vide letter no. 279/594/98/BNG dated 26/11/2019, for the period 2019-20 to 2020-21. The deviations observed in mining operation vis-à-vis approved document are given below:</p> <p>i) It was observed during site inspection that the 5 exploratory boreholes and 12 trial pits have been proposed during the year 2020-21, whereas only 3 boreholes have been dilled .The balance exploratory work has not been carried out so far.</p> <p>ii) It was observed during the inspection that the waste of 3,90,000 tonnes has been generated against the proposed waste of 2,68,232 tonnes during the year 2020-21. There is a lagging of development with deviation of 45% more than the proposed.</p>

02. In this connection, it is brought to your notice that the above violations constitute an offence punishable under Rule 62 of MCDR, 2017.
03. The mining operations can be suspended under rule 11(2), if compliance of rule 11(1) is not found satisfactory.
04. You are advised to rectify the above violations immediately and intimate the position to this office **within 45 (Forty-Five) days** from the date of issue of this letter.
