विषय/Subject: Violation of provisions of MCDR 2017 in respect of your Kadathi Mn ore Mine, ML 1616 over an extent of 2.02 ha in Kadathihalli Village, Harpanahalli Taluk, Davangere District of Karnataka State.

Sir,

The following provisions of the Mineral Conservation and Development Rules, 2017 were found violated in your above mine during inspection on 14.03.2022 by the undersigned in the presence of Shri A.P. Moses, Mines Manager, Shri S.Mohan Kumar, Geologist, Shri Shiva Raj, Mining Engineer.

Rules	Nature of Violations observed
11 (1)	Modification to the approved Mining plan was approved by IBM vide letter no. 279/933/2006/BNG/930 dated 04.05.2016, for the period 2016-17 to 2020-21. The deviations observed in mining operation vis-à-vis approved document are given below. i)It was observed during site inspection that the mine has produced only 7200 tonnes against the proposed production of 25003 tonnes during the year 2020-21. There is a deviation of 72% and during the year 2020-21 and the waste of 3300 tonnes has been generated against the proposed waste of 10657 tonnes. The deviation is 70% less development.

- 02. In this connection, it is brought to your notice that the above violations constitute an offence punishable under Rule 62 of MCDR, 2017.
- 03. The mining operations can be suspended under rule 11(2), if compliance of rule 11(1) is not found satisfactory.
- 04. You are advised to rectify the above violations immediately and intimate the position to this office within 45 (Forty-Five) days from the date of issue of this letter.
