The following provisions of the Mineral Conservation and Development Rules, 2017 were found violated in your above mine during inspection on 14.03.2022 by the undersigned in the presence of Shri A.P. Moses, Mines Manager, Shri S.Mohan Kumar, Geologist, Shri Shiva Raj, Mining Engineer

| 11 (1) | Modification to the approved Mining plan was approved by IBM vide letter no. 279/932/2006/BNG dated 31/03/2016, for the period 2016-17 to 2020-21. The deviations observed in mining operation vis-à-vis approved document are given below:<br>i) It was observed during the inspection that during the year 2020-21, the construction of 75mx 1.5m x 2.0m of retaining wall and 75mx 1.0m x 1.5m of Garland drain has been proposed. The same has not been carried out. |

- In this connection, it is brought to your notice that the above violations constitute an offence punishable under Rule 62 of MCDR, 2017.
- The mining operations can be suspended under rule 11(2), if compliance of rule 11(1) is not found satisfactory.
- You are advised to rectify the above violations immediately and intimate the position to this office **within 45 (Forty-Five) days** from the date of issue of this letter.
