The following provisions of the Mineral Conservation and Development Rules, 1988 were found violated in your above mine during the inspection made on 12.01.2017 by the undersigned in presence of Shri Satish Tomar, Owner's Representative

**Rule No. Nature of violation observed in detail**

- 13(1)** The mining operations are carried out in violation of following provisions of approved Review & Updation of Mining Plan (Approved on 08-06-2016): -  
1) In Para 2.0 it was proposed to develop mine by forming benches each of 6m in height with width more than the height whereas at some places the height of the benches more than 10m with vertical and irregular faces have been developed.
- 23(E)(2):** A yearly report to be submitted before 1<sup>st</sup> July of every year setting forth the extent of protective and rehabilitation works carried out as envisaged in the approved mine closure plan has not been submitted to this office for the year 2015-16.
- 45(5) (a)** Monthly returns for month of December 2016 has not been submitted to this office.
- 45(5) (b):** Annual return for the year 2015-16 has not been submitted to this office.
02. In this connection, it is brought to your notice that the above violations constitute an offence punishable under Rule 58 of MCDR, 1988.
03. The mining operation can be suspended under rule 13(2) of MCDR 1988 if compliance of rule 13(1) of MCDR 1988 is not found satisfactory.
04. You are advised to rectify the above violations immediately and intimate the position to this office on letter pad signed by the owner within 45 (forty-five) days from the date of issue of this letter.
